****NOTE:** The fewer selections you make, the longer it will take to accommodate your transfer request. The majority of the portfolio is comprised of 2 and 3 bed units, there are VERY few 1 bed and 4 bed units available. **It is suggested that ALL families on the internal transfer wait list also have an active application at Access To Housing (350 King St E Suite 110) as another housing provider may be able to offer you housing prior to Kiwanis Homes being able to offer you a transfer.**

The City of Hamilton provides transfer criteria as follows:

1. Priority is given to victims of abuse (currently at risk of life and limb)
2. Families who are overhoused (ie. too many bedrooms for size of family)
3. Families wishing to move for urgent reasons ie. stairs, allergens, social issues – supporting documents required (doctor note, police report)
4. Families who are underhoused (ie. not enough bedrooms for family size)
5. All other transfer requests

To be eligible for a transfer, you must have resided in your unit for at least a year, your rental account must be up to date and you must have paid your rent in full on the first of each month for at least the previous six months. Effective January 1, 2021 you will receive ONE offer of alternate housing.
